## CANCELLATION POLICY FOR SHORT-TERM ONLINE PROGRAMS

#### **AS APPLIED TO VENUES**

If a venue cancels a confirmed MASC booking for any reason, they must contact **both** MASC and the artist. The artist's contact information is on the MASC Confirmation form.

Notice of Cancellation	Activity is rescheduled with the same artist*	Activity is not rescheduled with the same artist*
Within 3-5 business days, prior to the booking day.	No surcharge	The venue will be responsible for 50% of the original invoice, which will be credited to the artist.
Within 0-2 business days, prior to the booking day (this includes lockdown or fire drills) or failure to provide connection link on time.	50% of the total invoice will be added to the rescheduled invoice and credited to the artist.	The venue will be responsible for 100% of the original invoice, which will be credited to the artist.
Force Majeure: technical difficulties**, severe weather conditions, strike actions, changes in Public Health safety protocols, venue closures, power failures, illness related outbreaks, lockdown or fire (excluding drills) etc.	No surcharge	No charge will be made to the venue, and no payment will be made to the artist.

\*MASC will also bill the venue, and reimburse the artist, for 100% of any material or equipment rental expenses incurred that cannot be reversed.

\*\*MASC technical difficulties definition includes internet failure, or low streaming quality only, beyond the artist's control.



## CANCELLATION POLICY FOR SHORT-TERM ONLINE PROGRAMS

#### **AS APPLIED TO MASC ARTISTS**

If an artist cancels a MASC booking for any reason, they must contact **both** MASC and the venue. The venue's contact information is on the MASC Confirmation form.

Notice of Cancellation	Activity is rescheduled with the same artist	Activity is not rescheduled with the same artist *
Within 3-5 business days, prior to the booking day.	No penalty	10% will be deducted from artist's next payment and credited to the venue.
Within 0-2 business days, prior to the booking day.	10% deducted from artist's fee and credited to venue for the rescheduled booking	20% will be deducted from artist's fees and credited to the venue.
Failure to appear	30% deducted from artist's fee and credited to the venue for the rescheduled booking	40% will be deducted from artist's next payment and credited to the venue.
Force Majeure: technical difficulties**, severe weather conditions, illness, death in the family, accident, venue failure to respect code of conduct etc.	No penalty	No charge will be made to the venue, and no payment will be made to the artist.

\*If the artist has been paid for the booking and there is no future payment due to the artist, the artist will be expected to reimburse MASC this amount, which will then be credited to the venue within a timeframe discussed with MASC.

\*\*MASC technical difficulties definition includes internet failure, or low streaming quality only, beyond the artist's control.



### **CANCELLATION POLICY FOR ONLINE RESIDENCIES**

#### **AS APPLIED TO VENUES**

If a venue cancels a confirmed Residency for any reason, they must contact **both** MASC and the artist. The artist's contact information is on the MASC Confirmation form.

Notice of Cancellation	Remaining activities are rescheduled with the same artist*	Remaining Activities are NOT rescheduled with the same artist*
Within 11-20 business days, prior to the booking day.	A 10% per day surcharge for remaining activities will be added to the rescheduled invoice and credited to the artist.	Venue will be charged 20% per day of the remaining activities, which will be credited to the artist.
Within 0-10 business days, prior to the booking day (including lockdown and fire drills) or failure to provide connection link on time.	A 30% per day surcharge for remaining activities will be added to the rescheduled invoice and credited to the artist.	Venue will be charged 50% per day of the remaining activities, which will be credited to the artist.
Force Majeure: strike actions, bus cancellations, severe weather conditions, changes in Public Health safety protocols, venue closures, power failures, illness related outbreaks, lockdown or fire (including drills) etc.	No surcharge	No charge will be made to the venue, and no payment will be made to the artist.

\*MASC will also bill the venue, and reimburse the artist, for 100% of any material or equipment rental expenses incurred that cannot be reversed.

### **CANCELLATION POLICY FOR ONLINE RESIDENCIES**

#### **AS APPLIED TO MASC ARTISTS**

If an artist cancels a confirmed Residency for any reason, they must contact **both** the venue and MASC. The venue's contact information is on the MASC Confirmation form.

Notice of Cancellation	Remaining activities are rescheduled	Remaining activities are NOT rescheduled
Within 11-20 business days, prior to the booking day	No surcharge	\$20 per day (capped at \$100) of the scheduled residency will be deducted from artist's fees and credited to the venue.
Within 0-10 business days, prior to the booking day	\$20 per day (capped at \$200) of the rescheduled residency will be deducted from the artist's next payment and credited to the venue.	\$40 per day (capped at \$400) will be deducted from artist's fees and credited to the venue.
Failure to appear	\$40 per day (capped at \$200) of the scheduled residency will be deducted from the artist's next payment and credited to the venue.	\$60 per day (capped at \$600) will be deducted from artist's fees and credited to the venue.
Force Majeure: severe weather conditions, changes in Public Health safety protocols, illness, death in the family, accident, venue failure to respect code of	No charge will be made to the venue, and no payment will be made to the artist.	No charge will be made to the venue, and no payment will be made to the artist.
